# **COOPERATIVE ONNECTION**

## **Building into 2024**

**OVER THE PAST EIGHT DECADES**, the board and management of New Enterprise Rural Electric Cooperative have worked to improve the quality of life in the cooperative service territory. Each of those years were building blocks that brought us to where we are today.

2023 was quite challenging and impacted the way we all live and move as free people. While news outlets report inflation is easing, the fact is, all of us are still feeling the punch of abnormal price increases on everything we buy. The cooperative is no different. Nearly every budget line item

for line construction material, vehicles, hardware, transformers and voltage regulators has increased 20% to 40% above what they were in 2020. Despite this adversity, your electric cooperative is in good shape and will continue to provide safe, reliable, and competitively priced electric service to the membership.

In the coming year, we will continue to build on the cooperative's previous successes. Our right-of-way maintenance plan has put our system in a great position to handle the adverse weather conditions we experience as seasons change. While we cannot guarantee our system will always be stronger than all weather-related events — or misguided vehicles — our six-year right-of-way cycle is helping us preserve the integrity of the distribution system and provide a reliable flow of electricity. Also, I'd like to thank all of our members who are on the alert for trees that pose threats to our lines. As always, feel free to give us a call if you have a tree like this, and we will be more than happy to come out and take a look.

In 2023, the cooperative added a new service bucket truck, featuring a Ford F-600 chassis with a 45-foot bucket truck. A welcome addition to the cooperative fleet, it replaces a bucket truck that has served the cooperative since 2007. The new unit provides line crews with flexibility, and allows them to access areas where ground space is limited.

You may have noticed the capital credits applied to your electric bill in December 2023. One of the benefits of cooperative membership is this return of margins, and the board is focused on continuing the capital credits program for years to come. To date, the cooperative has returned more than \$2 million to our members.

In 2024, the cooperative will be focused on upgrading poles and conductors throughout its territory, particularly in the Waterside service area. This project will coincide with plans to upgrade the Waterside substation. We will be replacing the aging wood-pole structure with an engineered steel package and increasing station voltage and capacity. The upgrades will provide decades of future electric load growth and allow our distribution system to work more efficiently.

Our current board and management are continuing to meet the outstanding standard of service and reliability set by those who came before us. We will continue to do our part to maintain the level of service the cooperative has always provided. We'll do this through the thoughtful, meaningful and efficient use of time and resources, which ensures our decisions make the cooperative better than it was before.

## THINK SAFETY WHEN OPERATING A GENERATOR

A valuable piece of equipment during a power outage, a generator can either be temporary or permanently installed.

A permanent generator is wired into a house by a qualified electrician using a transfer switch that prevents the generator from feeding electricity back into overhead lines, which can be deadly for lineworkers.

A temporary generator is powered by gasoline and should not be attached to a circuit breaker, fuse, or outlet. Before purchasing a generator, you need to know the wattage required to run the appliances you will attach to it. You also need to know the surge power, which is the power it takes to turn on an appliance.

Once you have purchased the proper generator, follow these tips from Safe Electricity to operate it:

- ▶ Read and follow all manufacturer operating instructions to properly ground the generator. Be sure you understand them before hooking up the generator.
- ▶ Never operate a generator in a confined area, such as a garage. Generators can produce numerous gases, including toxic and deadly carbon monoxide, and require proper ventilation.
- ▶ Generators pose electrical risks when operated in wet conditions so only use it then when necessary. Protect the generator by operating it under an open, canopy-like structure on a dry surface, where water cannot pool or drain under it. Always dry your hands before touching the generator.
- When you refuel the generator, make sure the engine is cool to prevent a fire if the tank overflows.
- ▶ Nothing should be plugged into the generator when you turn it on. This prevents a surge from damaging your generator and appliances.
- ▶ Be sure to keep children and pets away from the generator. It could burn them.
- ▶ Turn off and unplug all appliances and equipment being powered by the generator before shutting it down.
- Remember to perform maintenance between uses. Inspect the fuel and oil filters, spark plug, oil level, and fuel quality and start the generator on a regular basis.

### **Sales Tax Notices**

**ARE YOU PAYING SALES TAX** for your service? If so, call the cooperative's office, and we will see if you can be exempt from the tax. The Department of Revenue requires us to maintain a certificate, which members must sign for each metered service. If you received a form and did not return it to the office, you will be assessed the tax.

Signed forms are valid for three years. The cooperative will be sending forms within the next few months to those whose certificate expires this year.

Certain businesses are required to pay sales tax as well as landlords who keep a rental account in their name. If you have a business and are exempt, please include your sales tax exemption number on the form.

You will be exempt from the tax if the property is:

- a primary residence (doesn't matter if you own or rent the property)
- ▶ a vacation home
- used directly for manufacturing, mining, farming, dairy or ship-building operations performed as a business

- used for an organization or institutional activity by a religious organization, volunteer firefighters, non-profit educational organization, or charity holding a charitable exemption
- ▶ directly used by the purchaser in the production, delivery, or rendition of public utility service and/ or construction, alteration, or maintenance of public utility facilities other than buildings. Purchaser presently has on file with the Pennsylvania Public Utility Commission the following Tariff of Rates:
