Historic Day at New Enterprise REC

JULY 29 WAS A HISTORIC DAY at New Enterprise Rural Electric Cooperative (REC) as lawmakers — representing the House Consumer Protection, Technology & Utilities Committee and Environmental & Natural Resource Protection Committee, and the Senate Consumer Protection & Professional Licensure Committee — visited the cooperative.

The day highlighted rural electric cooperatives, their impact on their communities and their values. Most importantly, we addressed issues all Pennsylvania electric consumers are facing today.

Pennsylvania Rural Electric Association (PREA) staff was instrumental in coordinating the legislative visit. PREA is an

important organization that supports all 13 Pennsylvania rural electric cooperatives on legislative issues that affect us and the members we serve. Locally, Leroy Walls serves as president of the New Enterprise REC Board and chairman of the PREA Board.

State Rep. Danilo Burgos (D-Philadelphia), majority chairman of the Consumer Protection, Technology & Utilities Committee, opened the meeting by thanking New Enterprise REC and PREA for the opportunity to visit the cooperative. He then introduced attending members of the committees and legislative staff.

The discussion covered topics including grid reliability, wildfires, local cellular coverage, and the history and community impacts of electric cooperatives. Members of the committees asked questions about how electric cooperatives and consumers are being affected by artificial intelligence and how data-center growth is impacting existing power generation infrastructure.

After the discussion, lawmakers were treated to a high-voltage demonstration. They then toured the cooperative's facility, which included seeing bucket and digger trucks, as well as other equipment lineworkers use.

The day was a great opportunity for cooperative leaders and legislators to assemble and discuss important issues.

An Easy Way to Pay Your Bill

ANOTHER MONTH HAS GONE BY, and each new month starts the same — with the bills due. As you juggle work, take the kids to sporting events and activities, and manage your home, New Enterprise Rural Electric Cooperative (REC) can spare you the headache of finding additional time to pay your electric bill.

The easiest way to pay your bill is to sign up for AutoPay with your checking account or a credit/debit card. After you sign up, we will automatically process your payment

on the 20th of each month or the next business day, if the 20th falls on a holiday or weekend.

You will still receive a monthly bill, which includes your account balance. With AutoPay, however, you don't have to worry about mailing your payment in on time, remember to pay it online or risk being disconnected for non-payment.

If you need to make changes to your AutoPay, call our office at 814–766–3221 or 800–270–3177 no later than the 12th of each month to give us enough time to update your account. As an additional bonus, you will receive a one-time \$5 bill credit for signing up.

You can create an account at newenterpriserec.com or download the SmartHub app to have instant access. You will receive notifications when your bill is ready, and you will then be able to schedule your payment.

If you don't opt to use AutoPay and SmartHub, you can mail your payment to our office, but please allow ample time for it to arrive. You can also pay your bill through online banking; drop your payment off in-person at the office; or use our drive-up drop box so you don't have to leave your vehicle. If you need assistance, reach out to the office, and we will gladly assist you.



You are important to us

New Enterprise REC occasionally needs to reach out to our members to discuss billing questions, planned outages, tree trimming, pole replacements or service work. Unfortunately, many of the phone numbers we have on file are out of service or now belong to another person, which makes it difficult to reach our members.

Your primary phone number is printed at the bottom of your monthly bill (see example below). Please review the number listed. If it is incorrect, put a line through the number and write the correct number. You can also list a mobile number or work number. You can also call the office to provide us with the correct number.

If you participate in paperless billing, you can view your bill online or through the SmartHub app. If you need to make a change, please call the office with the correct phone number.
